<u>Clinical Placement – Clinic I (CLE100)</u> Type of Work Experience	-	24 hours Duration in Hours

1. Clinical Placement – Clinic I is a required part of the Doctor of Naturopathic Medicine - Year 1 in which the student obtains practical skills relevant to the learning objectives of the program.

Clinic I provides an introduction to clinic operations and observation of patient care. Students observe primary interns (4th-year students) and a clinical faculty member. Six 4 hour shifts are required to be observed in year 1 of the program.

Learning Objectives and Outcomes:

A student who successfully completes this course will:

- develop insight into the various roles and responsibilities of clinic supervisors, staff and clinicians.
- have an introductory knowledge of the various aspects of the clinic.
- have a working knowledge of the clinic resources.
- understand the timing of clinic rotations and patient visits and the function of preview and review.
- have observed the clinician interaction with respect to case presentation, discussion and development of a treatment plan.
- 2. The requirements for participation in the work experience are as follows: Required Texts/readings:
 - CCNM-Boucher Clinic Intern Handbook
 - CCNM-Boucher Clinic Dress Code

- 3. The process by which the student will be placed in a work experience is as follows: Students will be assigned to groups A & B. The groups are then assigned to 6 rotations on different weeks. Each student is assigned to a certain clinic shift/clinic supervisor. The schedule will be sent out to the students before the start of the term.
- 4. The process by which the student will be evaluated in relation to the work experience component is as follows:
 - a) Clinic Observation: Observation of patient care will take place in the Boucher campus clinic (Boucher Naturopathic Clinic BNC). Students will be assigned to one four-hour observation rotation on one of these days to attend once every 2 weeks.
 - b) Small Group Tutorials: Small group tutorials will provide an opportunity to debrief on the clinical experience and to reflect on and discuss specific module topics relating to the course learning objectives.
- 5. Clinic I Assessment:
 - Assignment (including Observation Notes) x 2 Reflection Assignments are due for submission one week after that module group session 30% per assignment (25% of the grade for the reflection assignment + 5% for observation notes) = 60% of Total Grade
 - Participation Ongoing 40% Based on small group participation
